








Figure 1. Test circuit for  $V_{(\text{BR})\text{CEO}}$




Figure 2. Test circuit for switching characteristics – resistive load




Figure 3. Test circuit for switching characteristics – inductive load




Figure 4.  $V_{CEW}$  - Diagram




Figure 7.  $P_{tot}$  vs.  $T_{case}$




Figure 5.  $I_C$  vs.  $V_{CE}$




Figure 8.  $V_{CEsat}$  vs.  $I_B$




Figure 6.  $h_{FE}$  vs.  $I_C$




Figure 9.  $h_{FE}$  vs.  $I_C$




Figure 10.  $t_s$  vs.  $-I_{B2}/I_{B1}$




Figure 12.  $t_f$  vs.  $-I_{B2}/I_{B1}$




Figure 11.  $t_s$  vs.  $-I_{B2}/I_{B1}$






Figure 13.  $t_f$  vs.  $-I_{B2}/I_{B1}$

Collector connected with metallic surface





## Ozone Depleting Substances Policy Statement

It is the policy of **Vishay Semiconductor GmbH** to

1. Meet all present and future national and international statutory requirements.
