

Description

The TSOP18.. – series are miniaturized receivers for infrared remote control systems. PIN diode and preamplifier are assembled on lead frame, the epoxy package is designed as IR filter.

The demodulated output signal can directly be decoded by a microprocessor. The main benefit is the reliable function even in disturbed ambient and the protection against uncontrolled output pulses.










Figure 1. Frequency Dependence of Responsivity




Figure 2. Sensitivity in Bright Ambient




Figure 3. Sensitivity vs. Electric Field Disturbances




Figure 4. Sensitivity vs. Supply Voltage Disturbances




Figure 5. Sensitivity vs. Supply Voltage




Figure 6. Output Function




Figure 7. Output Pulse Diagram




Figure 8. Supply Current vs. Ambient Temperature




Figure 9. Sensitivity vs. Ambient Temperature




Figure 10. Supply Current vs. Supply Voltage




Figure 11. Relative Spectral Sensitivity vs. Wavelength





Figure 12. Directivity

Ozone Depleting Substances Policy Statement

- 1. Meet all present and future national and international statutory requirements.

- 3. Council Decision 88/540/EEC and 91/690/EEC Annex A, B and C (transitional substances) respectively.

Vishay Semiconductor GmbH can certify that our semiconductors are not manufactured with ozone depleting substances and do not contain such substances.
