The supreme heat dissipation of TELUX<sup>™</sup> allows applications at high ambient temperatures.


All packing units are binned for luminous flux, forward voltage and color to achieve the most homogenous light appearance in application.




Figure 1. Power Dissipation vs. Ambient Temperature





Figure 2. Forward Current vs. Ambient Temperature




Figure 4. Rel. Luminous Intensity vs. Angular Displacement





Figure 5. Percentage Total Luminous Flux vs. Total Included Angle for 60  $^{\circ}$  emission angle





Figure 6. Thermal Resistance Junction Ambient vs. Cathode Padsize

# **Ozone Depleting Substances Policy Statement**

It is the policy of Vishay Semiconductor GmbH to

- 1. Meet all present and future national and international statutory requirements.
- 2. Regularly and continuously improve the performance of our products, processes, distribution and operatingsystems with respect to their impact on the health and safety of our employees and the public, as well as their impact on the environment.

- 3. Council Decision 88/540/EEC and 91/690/EEC Annex A, B and C (transitional substances) respectively.
