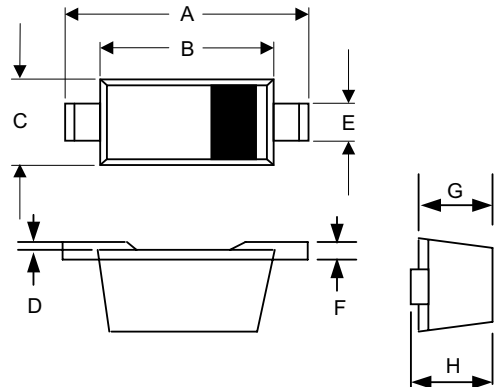

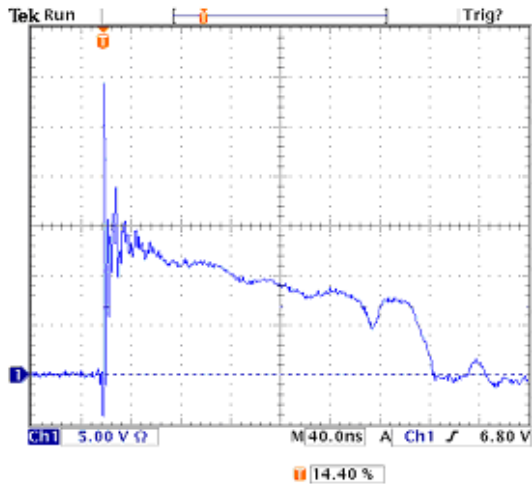


Figure 3. Positive 8 kV Contact per IEC 6100-4-2

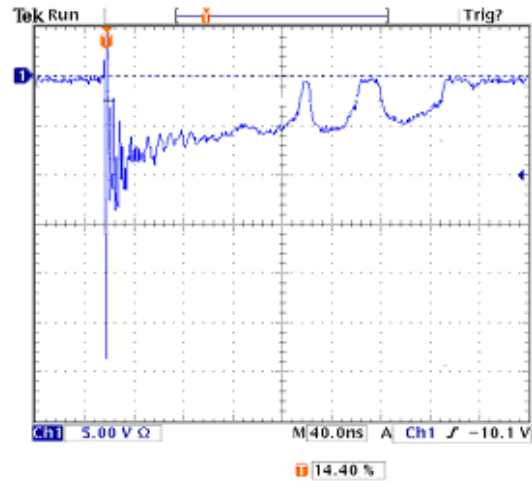


Figure 4. Negative 8 kV Contact per IEC 6100-4-2
