




Figure 3. Normalized avalanche power derating versus pulse duration

Figure 4. Normalized avalanche power derating versus junction temperature





Figure 5. Non repetitive surge peak forward current versus overload duration (maximum values, per diode)


Figure 6. Relative variation of thermal impedance, junction to case, versus pulse duration

Figure 8. Junction capacitance versus reverse voltage applied (typical values, per diode)








Figure 9. Forward voltage drop versus forward current (per diode)

Figure 10. Thermal resistance junction to ambient versus copper surface under each lead









Figure 11. Footprint (dimensions in mm)






Figure 12. Tape and reel specifications
