

Then, for normal switching operation, $V_{GS(ON)}$ must be higher than V_{th} , and $V_{GS(OFF)}$ must be lower than V_{th} . 


Fig. 5.3.1 Test Circuit of Switching Time




Fig. 5.3.2 Input Waveform/Output Waveform





Fig. 7.12 Dynamic Input/Output Characteristics





