

General Description

The TriQuint T1G2028536-FL is a 285 W (P_{3dB}) discrete GaN on SiC HEMT which operates from DC to 2 GHz. The device is constructed with TriQuint's proven TQGaN25HV process, which features advanced field plate techniques to optimize power and efficiency at high drain bias operating conditions. This optimization can potentially lower system costs in terms of fewer amplifier line-ups and lower thermal management costs.





Median Lifetime




Maximum Channel Temperature





Performance measured in TriQuint's 1.2 GHz to 1.4 GHz Evaluation Board at 3 dB compression.





Evaluation Board Performance (1, 2)


Performance at 3 dB Compression

Application Circuit



Bias-up Procedure

- Set gate voltage (V_G) to -5.0V
- Set drain voltage (V_D) to 36 V
- Slowly increase V_G until quiescent I_D is 576 mA.

Apply RF signal

Bias-down Procedure


Turn off RF signal

Turn off V_{D} and wait 1 second to allow drain capacitor dissipation

Turn off V_G

Evaluation Board Layout

Top RF layer is 0.020" thick Rogers RO4350, ε_r = 3.48. The pad pattern shown has been developed and tested for optimized assembly at TriQuint Semiconductor. The PCB land pattern has been developed to accommodate lead and package tolerances.






