The 74AHC2G08-Q100 and 74AHCT2G08-Q100 are high-speed Si-gate CMOS devices. They provide two 2-input AND gates.

The AHC device has CMOS input switching levels and supply voltage range 2 V to 5.5 V.

The AHCT device has TTL input switching levels and supply voltage range 4.5 V to 5.5 V.

This product has been qualified to the Automotive Electronics Council (AEC) standard Q100 (Grade 1) and is suitable for use in automotive applications.












Fig 7. Package outline SOT505-2 (TSSOP8)




Fig 8. Package outline SOT765-1 (VSSOP8)
