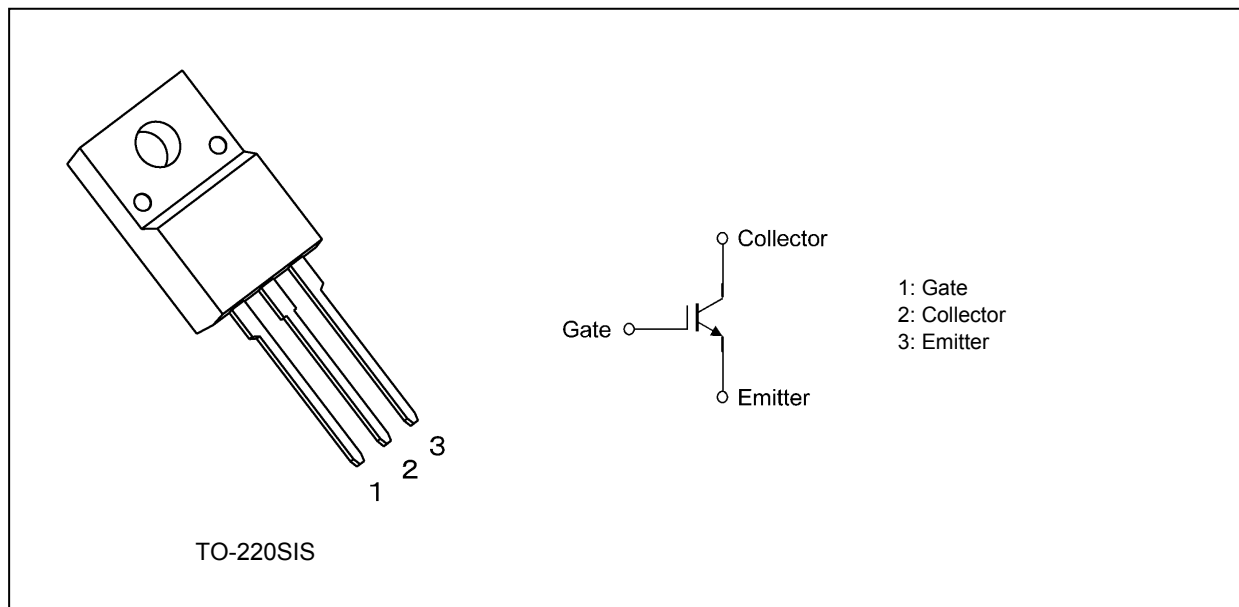

Note 1: Ensure that the junction temperature does not exceed  $150^\circ\text{C}$ .

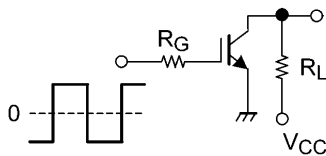


Fig. 6.2.1 Test Circuit of Switching Time

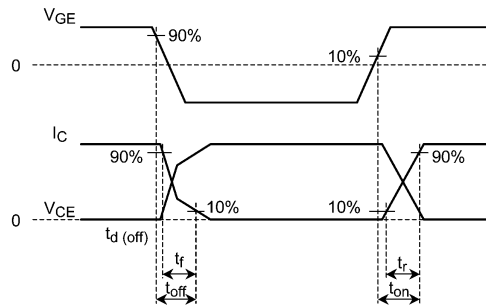


Fig. 6.2.2 Timing Chart of Switching Time

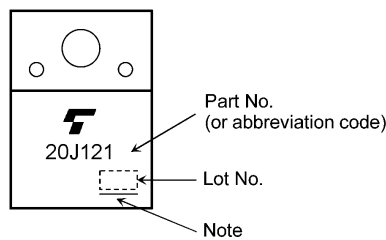


Fig. 7.1 Marking

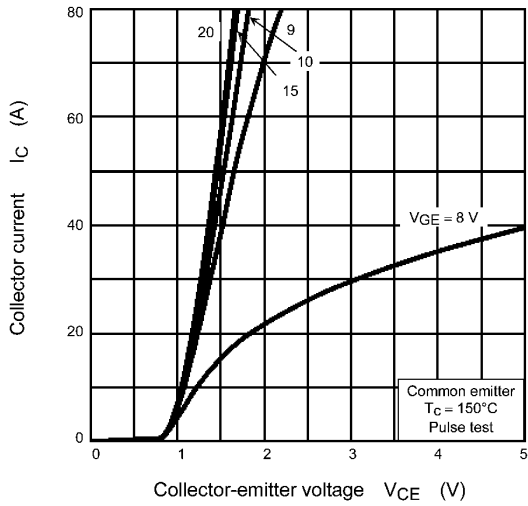

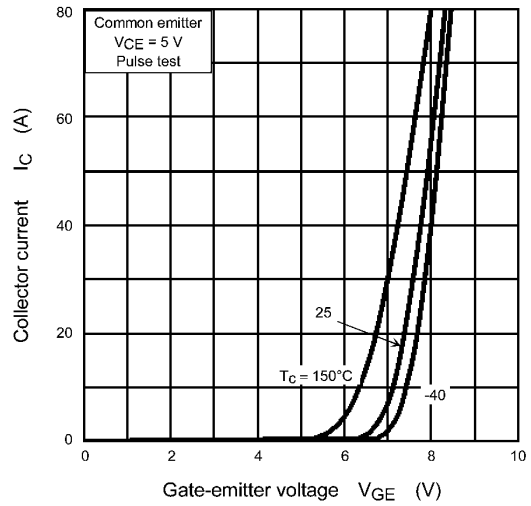
**Fig. 8.1  $I_C - V_{CE}$**



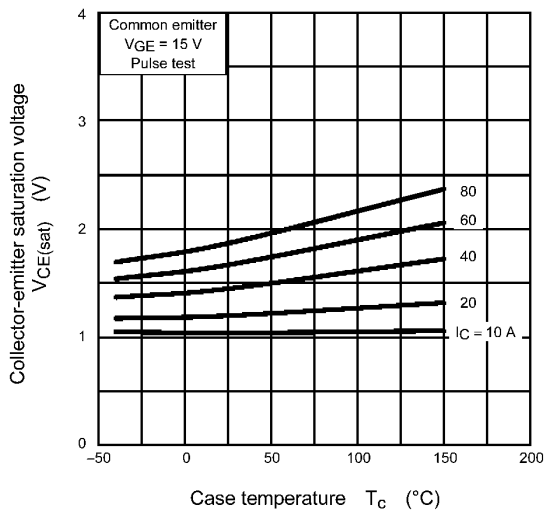
**Fig. 8.2  $I_C - V_{CE}$**



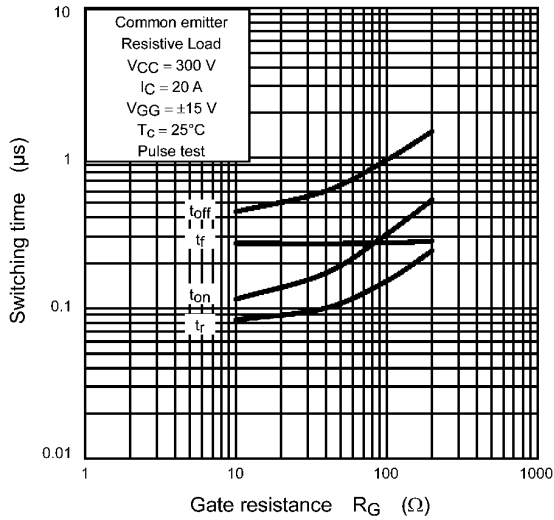
**Fig. 8.3  $I_C - V_{CE}$**



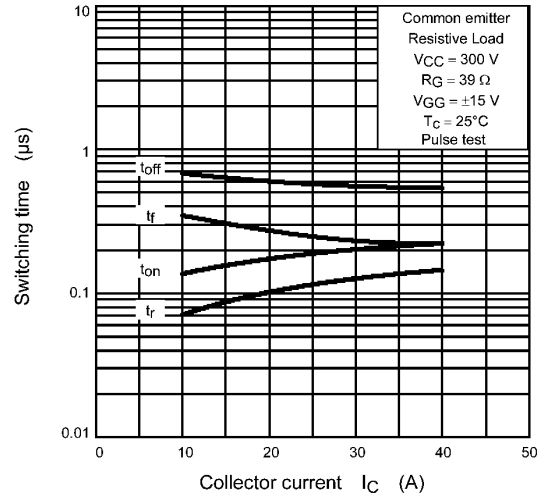
**Fig. 8.4  $I_C - V_{GE}$**



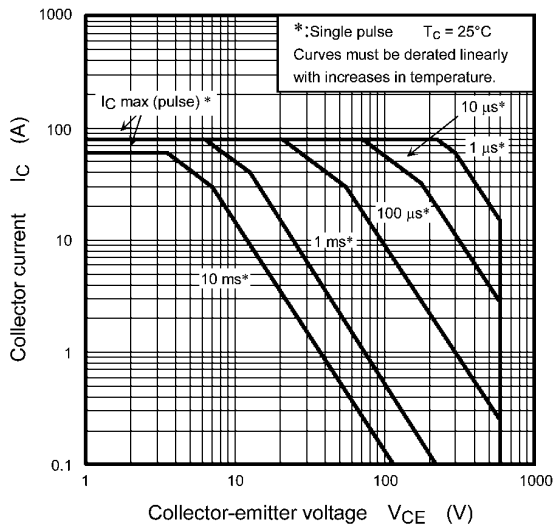
**Fig. 8.5  $V_{CE(sat)} - T_C$**



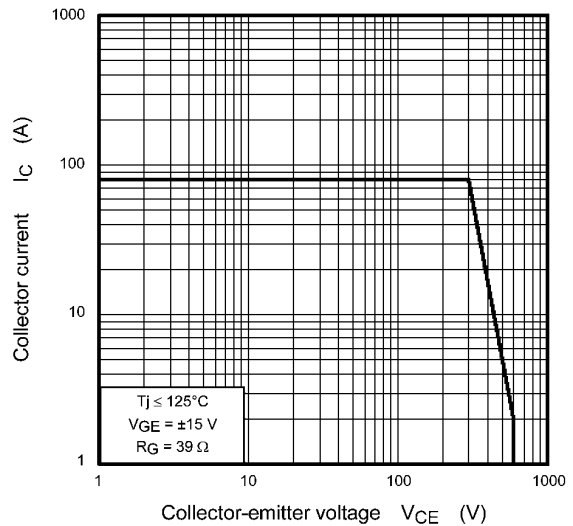
**Fig. 8.6 Switching Time -  $R_G$**



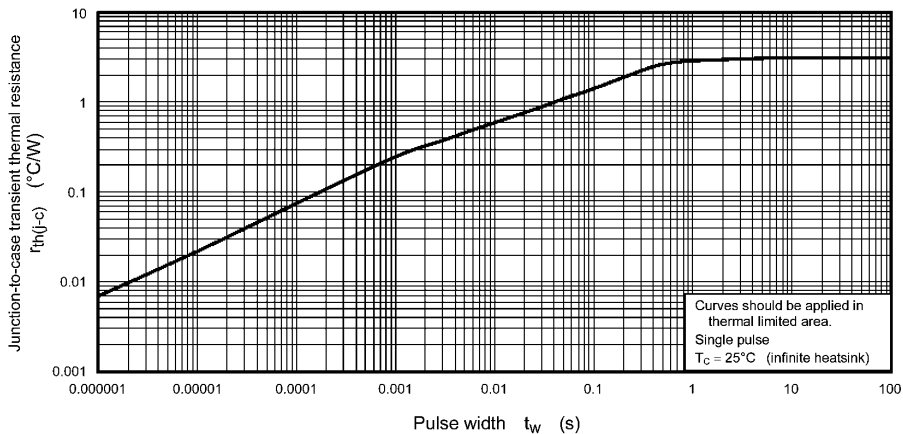
**Fig. 8.7 Switching Time -  $I_C$**

**Fig. 8.9 Reverse Bias SOA (Guaranteed Maximum)**

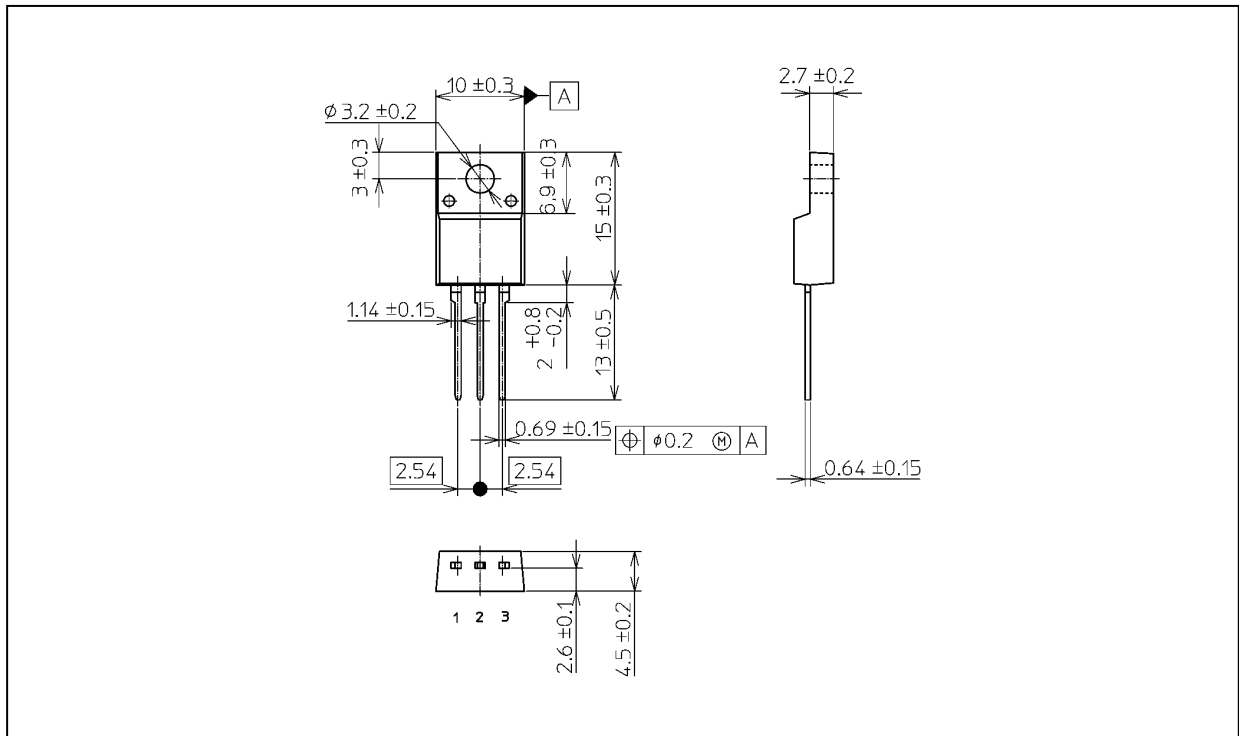


**Fig. 8.10  $r_{th(j-c)} - t_w$  (Guaranteed Maximum)**
