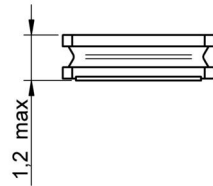
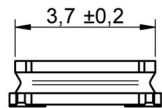
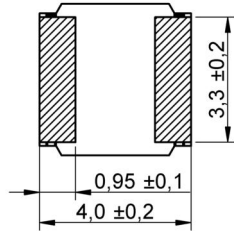


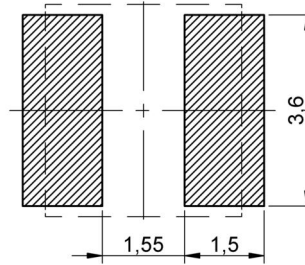

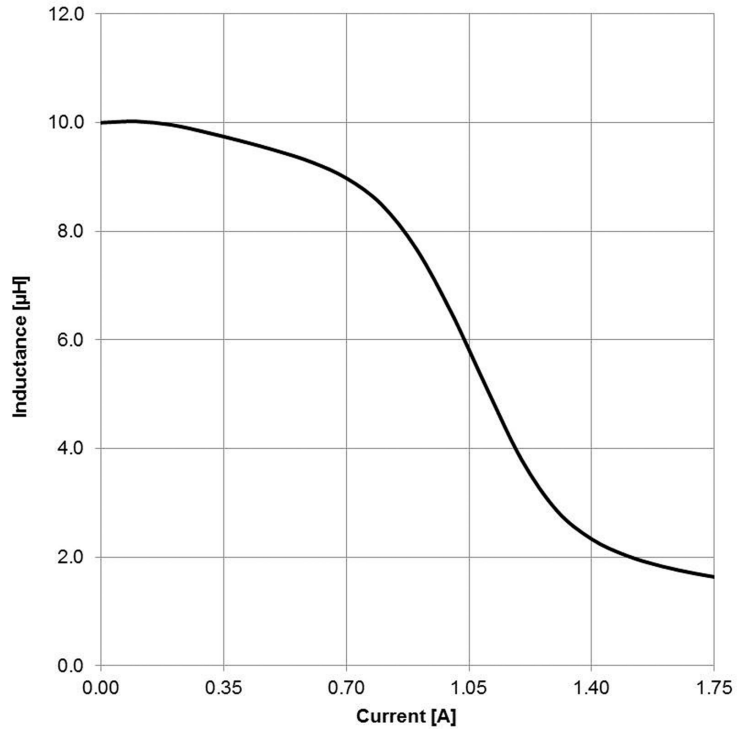

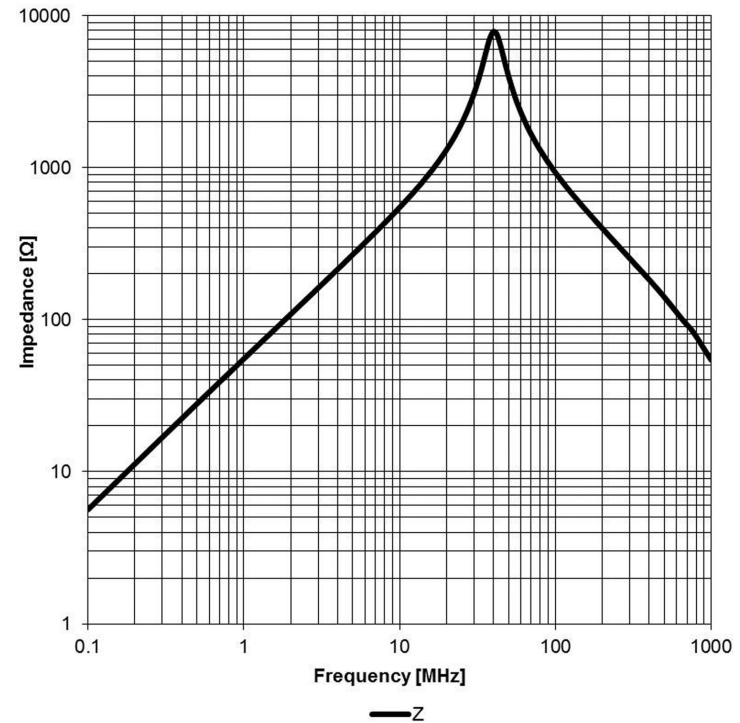



### Product specific:

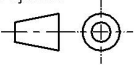
