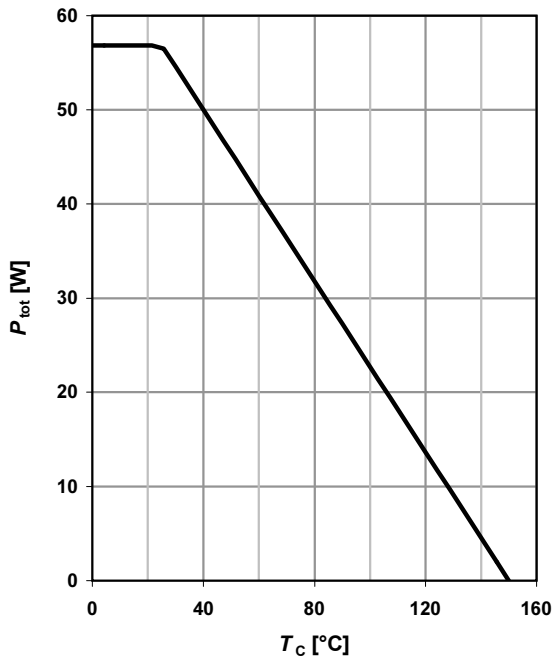

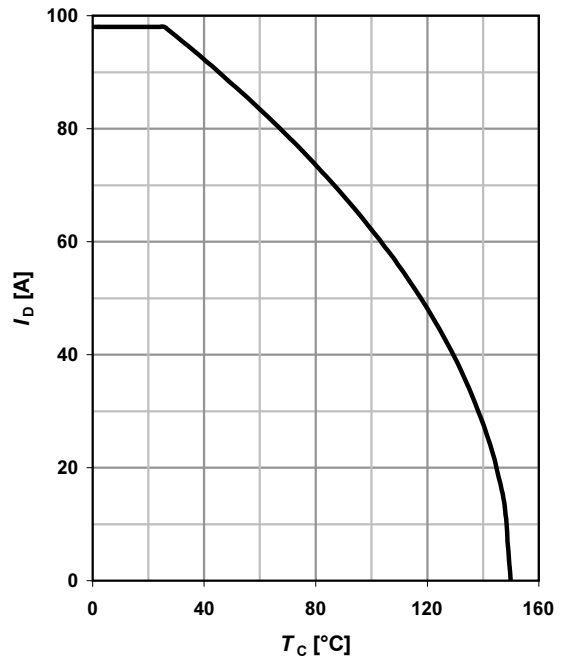

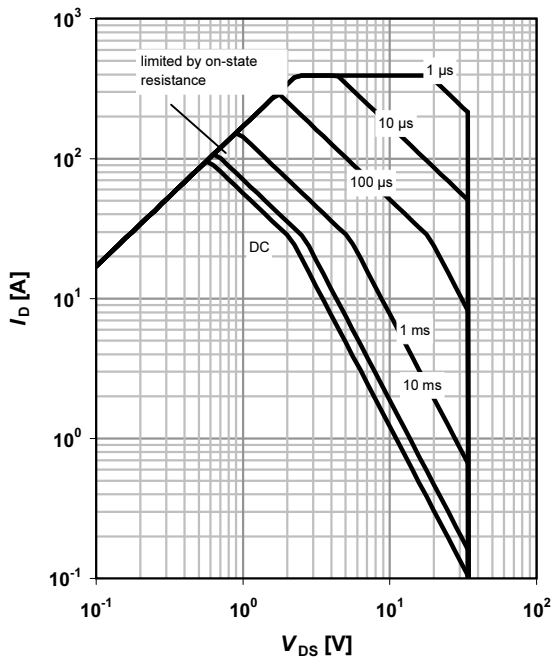

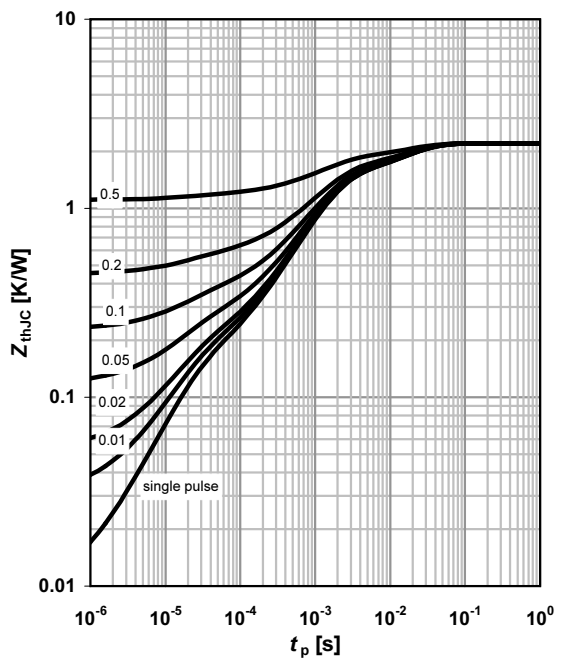

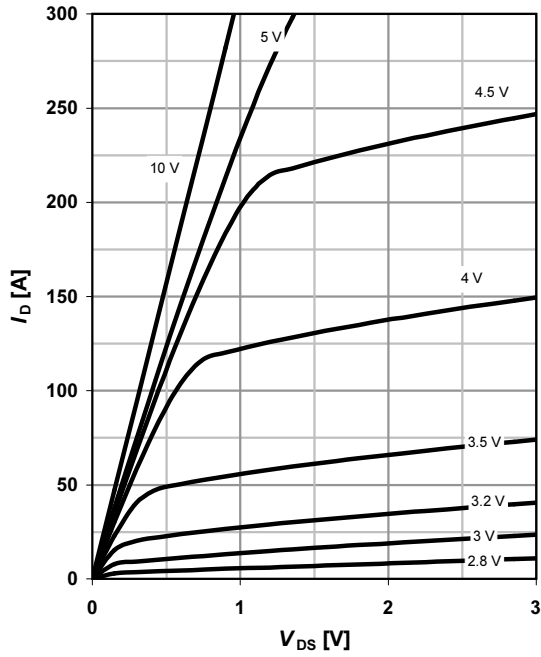

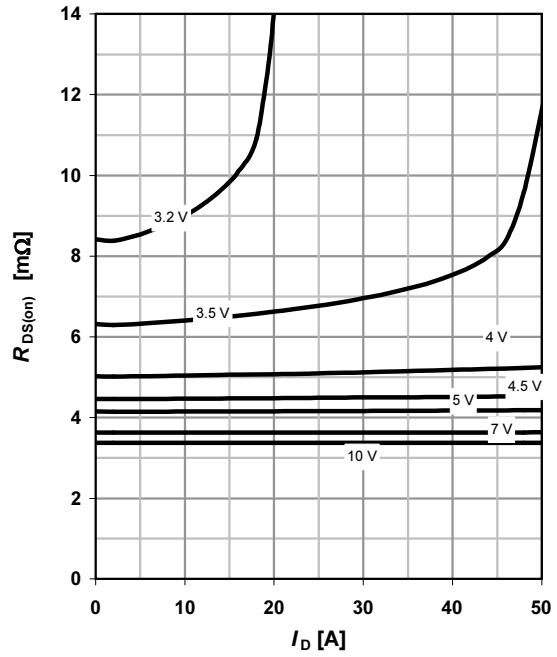

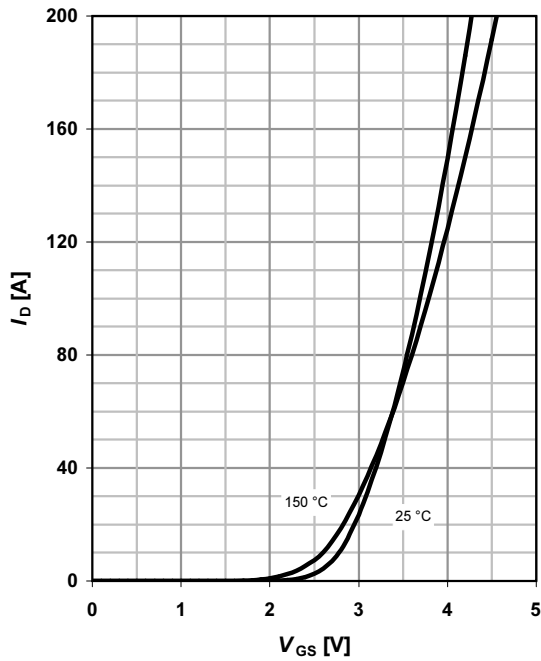

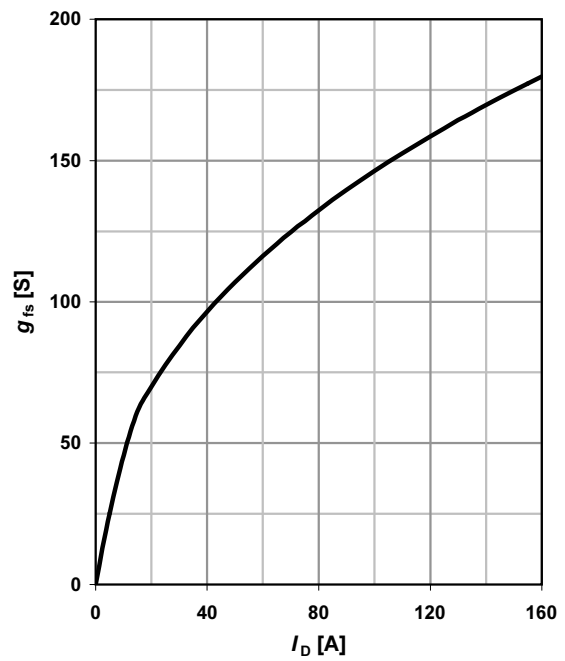

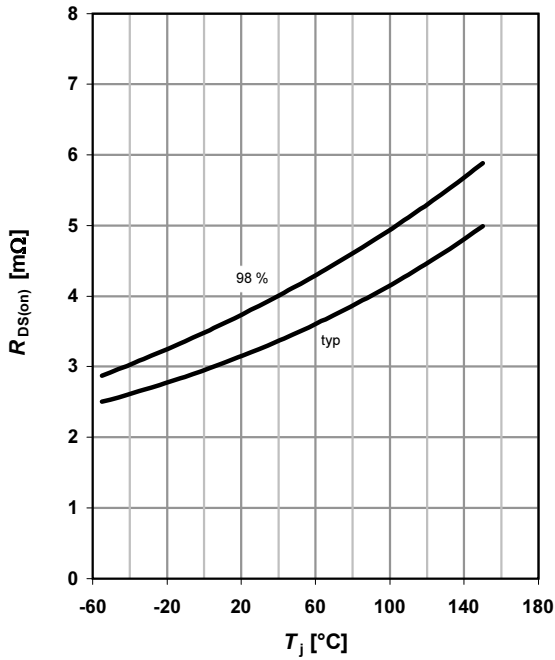
8 Typ. forward transconductance

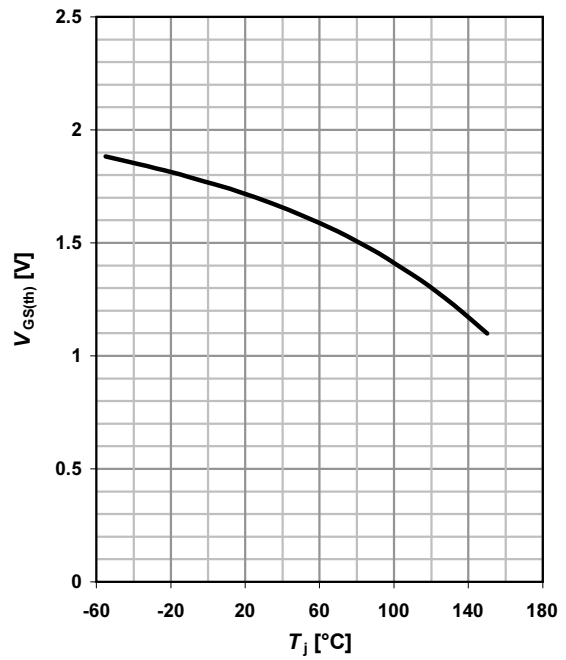
9 Drain-source on-state resistance

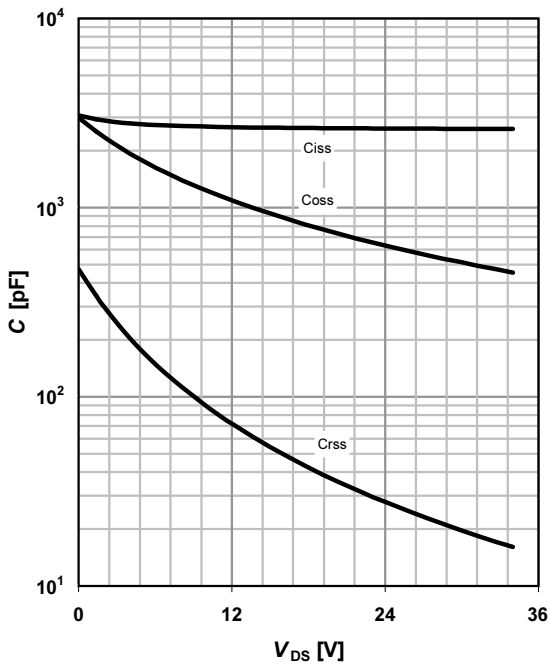
10 Typ. gate threshold voltage

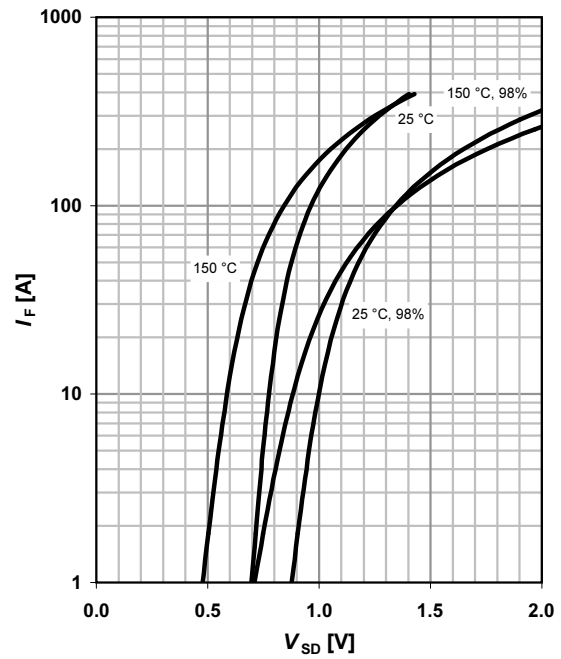

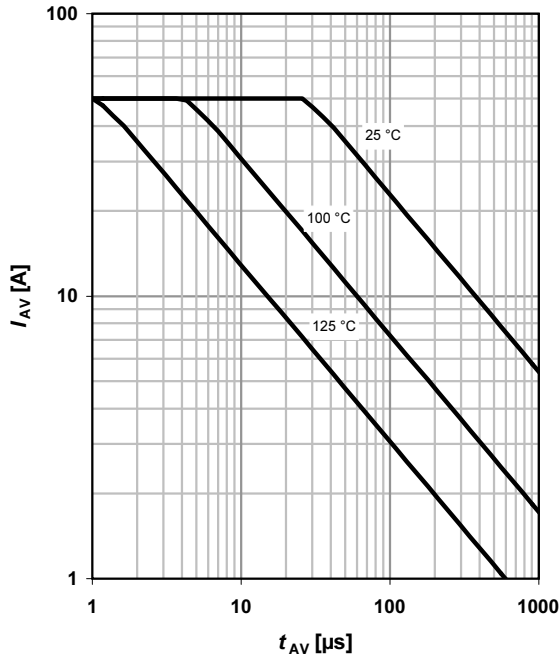

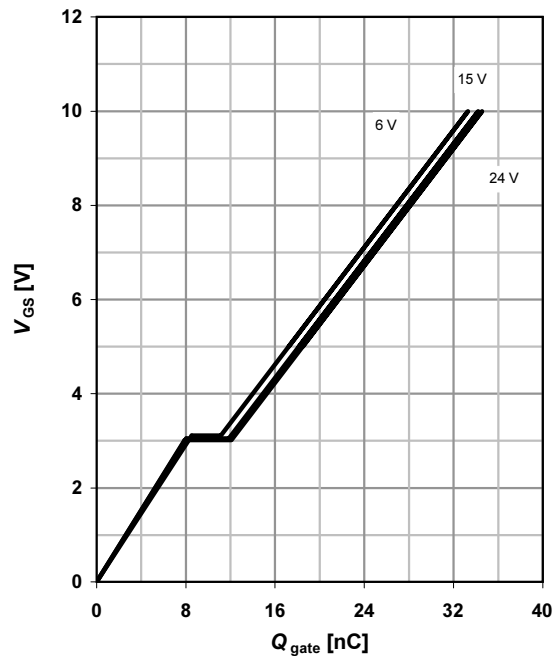

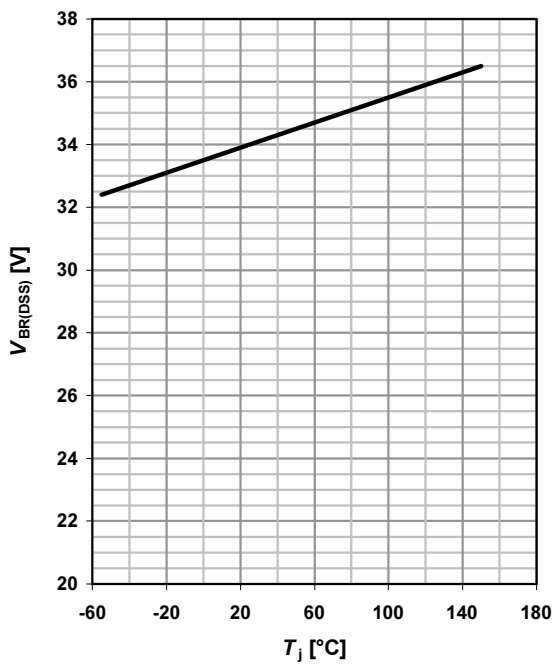

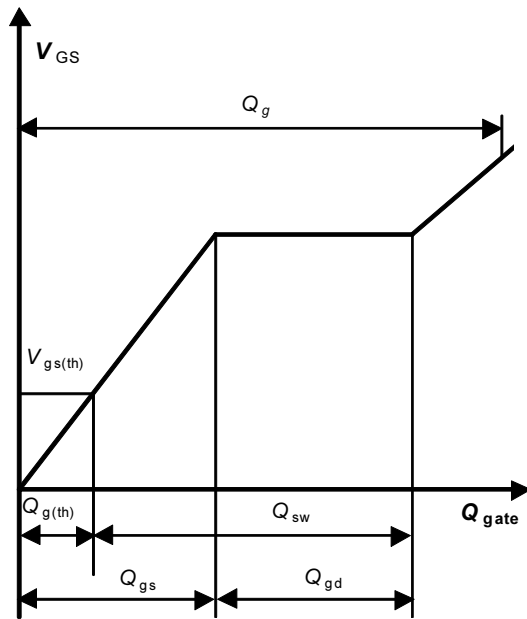


15 Drain-source breakdown voltage

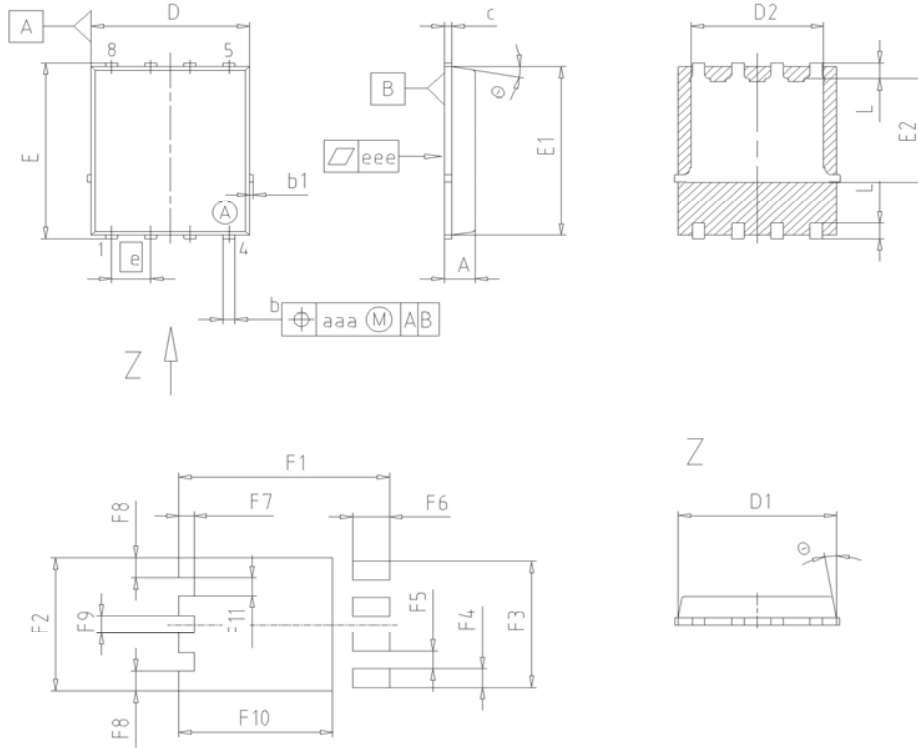
16 Gate charge waveforms
