
# Extented Power IR Emitting Diode in ø SMD Package

#### Description

TSML1000 is a high efficiency infrared emitting diode in GaAIAs on GaAs technology molded in clear SMD package

In comparison with the standard GaAs on GaAs technology these emitters achieve about 100 %

radiant power improvement at a similar wavelength. The forward voltages at low current and at high pulse current roughly correspond to the low values of the standard technology. Therefore these emitters are ideally suitable as high performance replacements of standard emitters.




Figure 1. Forward Current vs. Forward Voltage






Figure 2. Relative Forward Voltage vs. Ambient Temperature







### **Ozone Depleting Substances Policy Statement**

- 3. Council Decision 88/540/EEC and 91/690/EEC Annex A, B and C (transitional substances) respectively.

Vishay Semiconductor GmbH can certify that our semiconductors are not manufactured with ozone depleting substances and do not contain such substances.
