


F Typical Inductance vs. Current Characteristics:







Product specific:

Follow all instructions mentioned in the datasheet, especially:

- The solder profile has to be complied with according to the technical wave soldering specification, otherwise no warranty will be sustained
- •All products are supposed to be used before the end of the period of 12 months based on the product date-code, if not a 100% solderability can't be warranted.
- •Violation of the technical product specifications such as exceeding the nominal rated current will result in the loss of warranty.
- •Strong force and high accelerations of the component size 1014 might have the effect of damage the electrical connection or to harm the circuit board due to the heavy weight of the component. These damages will result in the loss of warranty.
