






FIGURE 3, Maximum Forward Current vs. Case Temperature




Figure 4. Maximum Power Dissipation vs. Case Temperature




Figure 6. Reverse Recovery Charge vs. V_R






Figure 5. Reverse Leakage Currents vs. Reverse Voltage
